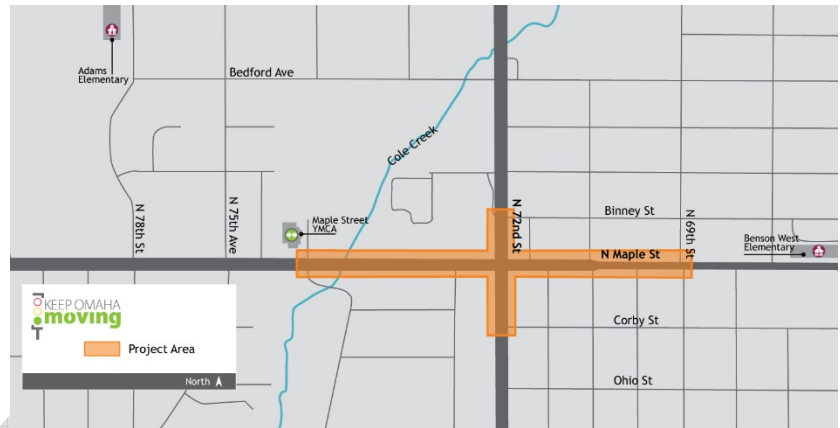

UTILITY RELOCATIONS WILL BE STARTING SOON!



Underneath our streets is a maze of utilities and other infrastructure. All Public Works projects include coordination with the local utility companies to include communications, gas, water, electricity, sewers, etc. This utility coordination happens early in the design stages in order to allow for utility companies to update any aging infrastructure and reduce utility related project impacts, if possible.

Prior to the 2020 start of construction for the 72nd & Maple Intersection Improvements Project, utility companies will be relocating and replacing their infrastructure. We realize that this will cause traffic disruption in the area, and want to make you aware of the timeline, and reasons for these delays. METROPOLITAN UTILITIES DISTRICT (MUD)

Metropolitan Utilities District (MUD) is replacing aging gas and water infrastructure starting in November 2018. Along with this plan, they are anticipating replacing approximately 1 mile of water main in the area, as well as approximately 2 miles of gas main in the area to improve service reliability to your home or business. Please note that these improvements may extend beyond the roadway project boundaries in some areas. These MUD improvements are expected to begin very soon and be done prior to the project's construction start in Spring 2020.



CLEAN SOLUTIONS FOR OMAHA (CSO)

The City's Clean Solutions for Omaha (CSO) program is working in the intersection of 70th & Maple to improve our combined sewer system. This project is Phase I of a larger effort in the Cole Creek Basin, and construction has been moved up to reduce additional impacts to the community in the future. This work is anticipated to start in Summer 2019.



OMAHA PUBLIC POWER DISTRICT (OPPD)

Omaha Public Power District (OPPD) is also relocating some power infrastructure to reduce impacts to new improvements for the area. OPPD is planning their relocations in early 2019.



**Please note that these utility relocation projects are not federally funded projects and are occurring independently of the Intersection Improvements.*
